In consultation with Bangladesh Supreme Court, Mr. Muhammad Omar Faruque, Attached Officer (Assistant Judge), Law and Justice Division (former Assistant Judge, Munshiganj) has been granted Study Leave from 25/08/2019 to 15/09/2020 for studying "LLM in International Humanitarian Law and Human Rights" at the Geneva Academy of International Humanitarian Law and Human Rights in Geneva, Switzerland through fully funded scholarship awarded by Hans wilsdorf Foundation, under the following terms and conditions :

 - f) Any stay abroad beyond the permitted period without prior permission of the Government of Bangladesh will be treated illegal;
 - g) He will not borrow any loan abroad and he will have to make payment of all the dues before his return;
 - h) As soon as the period of study leave ends, he will join the service and he will have to submit a copy of the course completion certificate on his return.
