5. Any stay beyond the permitted period in Australia without prior permission of the Government of Bangladesh will be treated as an illegal absence from service.
6. She will not borrow any loan in abroad and she will have to make payment of all the dues before her return.
7. She will have to submit a copy of the course completion certificate on her return.
8. She will have to return the salary and allowances drawn during the period of deputation to the Government in case of her failure to serve the Government at least two years from her return.
