

**Notification**

In consultation with Supreme Court of Bangladesh, Mr. Md ABBAS UDDIN (former Assistant Judge, Chakaria, Coxsbazar), Attached Officer (Assistant Judge), Law and Justice Division has been granted deputation from 05/09/2019 to 15/10/2020 for studying 'LLM in Civil Litigation and Dispute Resolution' at City University of London, UK funded by 'Chevening Scholarship' of the British Government, under the following terms and conditions :

- a) His period of deputation will be treated as on duty;
  - b) He will draw his pay and allowances in local currency;
  - c) The Government of Bangladesh shall not bear any expenditure in local or foreign currency for this study;
  - d) He will return to Bangladesh after period of deputation;
  - e) Any stay abroad beyond the permitted period without prior permission of the Government of Bangladesh will be treated illegal;
  - f) He will not borrow any loan abroad and will have to make payment of all the dues before his return;
  - g) As soon as the period of deputation ends, he will join the service and will have to submit a copy of the course completion certificate on his return;
  - h) He will have to return the salary and allowances drawn during the period of deputation to the Government in case of his failure to serve the Government at least two years from his return.
2. This order is issued with the approval of the competent authority.


