

**Notification**

In consultation with Supreme Court of Bangladesh, Mr. SAIDUZZAMAN SHARIF (former Metropolitan Magistrate, Dhaka), Attached Officer (Senior Assistant Judge), Law and Justice Division has been granted deputation from 08/09/2019 to 30/10/2020 for studying 'LLM in Criminal Law and Criminal Justice' at University of Sussex, UK funded by 'Prime Minister Fellowship' of the Government of Bangladesh, under the following terms and conditions :

- a) His period of deputation will be treated as on duty;
  - b) He will draw his pay and allowances in local currency;
  - c) He will return to Bangladesh after period of deputation;
  - d) Any stay abroad beyond the permitted period without prior permission of the Government of Bangladesh will be treated illegal;
  - e) He will not borrow any loan abroad and will have to make payment of all the dues before his return;
  - f) As soon as the period of deputation ends, he will join the service and will have to submit a copy of the course completion certificate on his return;
  - g) He will have to return the salary and allowances drawn during the period of deputation to the Government in case of his failure to serve the Government at least two years from his return.
