

**Notification**

In consultation with Supreme Court of Bangladesh, Ms. Shushmita Ahmed (former Judicial Magistrate, Chattogram), Attached Officer (Assistant Judge), Law and Justice Division has been granted deputation from 01/01/2020 to 10/03/2021 for studying 'Master of Environmental Law' at the University of Melbourne, Australia funded by 'Australia Awards Scholarship' of the Australian Government, under the following terms and conditions :

- a) Her period of deputation will be treated as on duty;
  - b) She will draw her pay and allowances in local currency;
  - c) She will return to Bangladesh after expiration of deputation;
  - d) Any stay abroad beyond the permitted period without prior permission of the Government of Bangladesh will be treated illegal;
  - e) She will not borrow any loan abroad and will have to make payment of all the dues before her return;
  - f) As soon as the period of deputation ends, she will join the service and will have to submit a copy of the course completion certificate on her return;
  - g) She will have to return the salary and allowances drawn during the period of deputation to the Government in case of her failure to serve the Government at least two years from her return.
2. This order is issued with the approval of the competent authority.


