
Notification

In consultation with the Supreme Court of Bangladesh, the Government of Bangladesh has granted deputation from 01/10/2020 to 31/10/2021 in favour of the following Judicial Officer for studying 'Master's Program in Law' at the Kyushu University, Japan funded by Young Leaders Program (YLP) of MEXT Scholarship 2020 of the Government of Japan under the following terms and conditions :

Sl.	Name	Designation and work place
1	Mr. Najmul Hossain Chowdhury	Attached Officer (Senior Assistant Judge) Law and Justice Division (former Legal Aid Officer, Barishal)

Terms and condition :

- a) The period of deputation will be treated as on duty;
 - b) He will draw pay and allowances in local currency;
 - c) He will return to Bangladesh after expiration of deputation;
 - d) Any stay abroad beyond the permitted period without prior permission of the Government of Bangladesh will be treated as illegal;
 - e) He will not borrow any loan abroad and will make payment of all the dues before his return;
 - f) As soon as the period of deputation ends, he will join the service and will submit a copy of the course completion certificate;
 - g) He has to return the salary and allowances drawn by him during the period of deputation in case of his failure to serve the Government at least for two years from his return.
2. This order is issued with the approval of the competent authority.


