Notification

In consultation with the Supreme Court of Bangladesh, the Government of Bangladesh has granted deputation from 20/09/2020 to 30/09/2022 in favour of the following Judicial Officer for studying "LL.M. (Comparative Law) Program in Law and Political Science" at the Nagoya University, Japan funded by Japanese Government (MEXT) Scholarship 2020 of the Government of Japan under the following terms and conditions :

Terms and condition :

- a) Period of deputation will be treated as on duty;
 - b) He will draw pay and allowances in local currency;
 - c) He will return to Bangladesh after expiration of deputation;
 - d) Any stay abroad beyond the permitted period without prior permission of the Government of Bangladesh will be treated illegal;
 - e) He will not borrow any loan abroad and will make payment of all the dues before his return;
 - f) As soon as the period of deputation ends, he will join the service and will submit a copy of the course completion certificate;
 - g) He has to return the salary and allowances drawn by his during the period of deputation in case of his failure to serve the Government at least two years from his return.
