Terms & Conditions:

- a) Period of deputation will be treated as on duty;

- d) Any stay abroad beyond the permitted period without prior permission of Government of Bangladesh will be treated illegal;
- e) She will not borrow any loan abroad and will make payment of all the dues before her return;
- f) As soon as the period of deputation ends, she will join the service and will submit a copy of the course completion certificate;
- g) She has to return the salary and allowances drawn by her during the period of deputation in case of her failure to serve the Government at least two years from her return.
