Terms and Conditions:

- a. The period of deputation will be treated as on duty;
- b. She will draw her pay and allowances in local currency;
- c. The Government of Bangladesh shall not bear any expenditure in local or foreign currency for this study;
- d. She will return to Bangladesh immediately after completion of the course;
- e. Any stay abroad beyond the permitted period without prior permission of the Government of Bangladesh will be treated as illegal;
- f. She will not borrow any loan in abroad and make payment of all the dues before her return;
- g. As soon as the period of deputation ends, she will join the service and submit a copy of the course completion certificate;
- h. She has to return the salary and allowances drawn by her during the period of deputation in case of her failure to serve the Government at least for two years from her return.
