

Terms and condition :

- a) This study leave will not be deducted from his account of leave;
 - b) He will not receive any study allowances;
 - c) During his study leave he will be entitled to his salary on half-average pay basis;
 - d) Any stay at the University beyond the permitted period without prior permission of the Government of Bangladesh will be treated as illegal;
 - e) As soon as the period of study leave ends, he will join the service and will have to submit a copy of the course completion certificate on his return.
 - f) He will have to return the salary and allowances drawn during the period of study leave to the Government in case of his failure to serve the Government at least for two years from his return.
