Terms and Conditions :

- a. The period of deputation will be treated as on duty;
- b. He will draw pay and allowances in local currency;
- c. He will return to Bangladesh after expiration of deputation;
- d. Any stay abroad beyond the permitted period without prior permission of the Government of Bangladesh will be treated as illegal;
- e. He will not borrow any loan in abroad and make payment of all the dues before his return;
- f. As soon as the period of deputation ends, he will join the service and will submit a copy of the course completion certificate;
- g. He has to return the salary and allowances drawn by him during the period of deputation in case of his failure to serve the Government at least for two years from his return;
