
Notification

In consultation with the Supreme Court of Bangladesh, the Government of Bangladesh has granted deputation from 05/09/2021 to 15/10/2022 in favour of the following Judicial Officer for studying 'LL.M in Information Technology and Intellectual Property Law' at the University of Sussex, UK funded by 'Chevening Scholarship' of the British Government, under the following terms and conditions :

Sl.	Name	Designation and work place
1	Mr. Baki Billah	Attached Officer, Law and Justice Division (former Metropolitan Magistrate, Dhaka)

Terms and condition :

- a) His period of deputation will be treated as on duty;
 - b) He will draw his pay and allowances in local currency;
 - c) The Government of Bangladesh shall not bear any expenditure in local or foreign currency for this study;
 - d) He will return to Bangladesh after the period of deputation;
 - e) Any stay abroad beyond the permitted period without prior permission of the Government of Bangladesh will be treated illegal;
 - f) He will not borrow any loan abroad and will have to make payment of all the dues before his return;
 - g) As soon as the period of deputation ends, he will join the service and will have to submit a copy of the course completion certificate;
 - h) He will have to return the salary and allowances drawn during the period of deputation in case of his failure to serve the Government at least two years from his return.
