Notification

In consultation with the Supreme Court of Bangladesh, the Government of Bangladesh has granted deputation for 12 (twelve) months from 15 March, 2021 or from the date of actual departure in favour of the following Judicial Officer for Deployment to the United Nations peace operations as government-provided justice personnel in United Nations Mission in Somalia (UNSOM) located in Somalia under the following terms and conditions:

Name	Designation and work place
Ms. Lubna Zahan	Attached Officer, Law and Justice Division (former Joint District and Sessions Judge, Jamalpur)

Terms and conditions :

- a) Period of deputation will be treated as on duty;
 - b) She will draw pay and allowances in local currency;
 - c) She will return to Bangladesh after expiration of deputation;
 - d) Staying abroad beyond the permitted period without prior permission of the Government of Bangladesh will be treated as illegal;
 - e) She will not borrow any loan in abroad and will make payment of all the dues before her return;
 - f) The daily Mission Subsistence Allowance will be paid and temporary accomodation arrangements will be made by UNSOM;
 - g) The "Guidelines on Non-Uniformed Civilian Government-Provided Personnel on Assignment with United Nations Peacekeeping and Special Political Missions", dated 01April 2015, reference 2015.01, shall be applicable.
