

Notification

Mr. Dhiman Chandra Mondal, Attached Officer, Law and Justice Division has been granted deputation from 28/05/2022 to 30/08/2023 or for fifteen months two days from the date of his departure for studying 'Master of Intellectual Property Law' at the University of Melbourne, Australia funded by 'Department of Foreign Affairs and Trade, Australia under the following terms and conditions:

Terms and conditions:

- a) His period of deputation will be treated as on duty.
 - b) He will draw his pay and allowances in local currency.
 - c) He will return to Bangladesh after the period of deputation.
 - d) Any stay abroad beyond the permitted period without prior permission of the Government of Bangladesh will be treated illegal.
 - e) He will not borrow any loan abroad and will have to make payment of all the dues before his return.
 - f) As soon as the period of deputation ends, he will join the service and will have to submit a copy of the course completion certificate.
 - g) He will have to return the salary and allowances drawn during the period of deputation in case of his failure to serve the Government at least two years from his return.
2. The notification bearing No. 10.00.0000.125.08.011.19.316, dated 31 August 2021 issued in favour of Mr. Dhiman Chandra Mondal is hereby cancelled.
