Notification

In consultation with the Supreme Court of Bangladesh, the Government of Bangladesh has granted deputation from 14/06/2022 to 30/08/2023 in favour of Mrs. Nusrat Sharmin, Attached Officer (former Senior Judicial Magistrate, Sylhet), Law and Justice Division for studying 'Master of Health and Medical Law' at the University of Melbourne, Australia funded by Department of Foreign Affairs and Trade, Australia under the following terms and conditions :

Terms and condition :

- a) Her period of deputation will be treated as on duty;
 - b) She will leave for Australia on 30 May 2022 or nearer possible date;
 - c) She will draw her pay and allowances in local currency;
 - d) The Government of Bangladesh shall not bear any expenditure in local or foreign currency for this study;
 - e) She will return to Bangladesh after the period of deputation;
 - f) Any stay abroad beyond the permitted period without prior permission of the Government of Bangladesh will be treated illegal;
 - g) She will not borrow any loan abroad and will have to make payment of all the dues before her return;
 - h) As soon as the period of deputation ends, she will join the service and will have to submit a copy of the course completion certificate;
 - i) She will have to return the salary and allowances drawn during the period of deputation in case of her failure to serve the Government at least two years from her return.
