
Notification

The Government of Bangladesh has granted deputation from 01/10/2022 to 30/09/2025 in favour of the following Judicial Officer for studying LL.D. (Comparative Law) Program in Law and Political Science on "A Comparative Study on Access to Justice and Small Civil Disputes: Prospects and Challenges for Bangladesh" at the Nagoya University, Japan funded by Japanese Government (MEXT) scholarship under the following terms and conditions :

Terms and condition :

- a) The period of deputation will be treated as on duty;
 - b) He will draw pay and allowances in local currency;
 - c) He will return to Bangladesh after expiration of deputation;
 - d) Any stay abroad beyond the permitted period without prior permission of the Government of Bangladesh will be treated illegal;
 - e) He will not borrow any loan abroad and will make payment of all the dues before his return;
 - f) As soon as the period of deputation ends, he will join the service and will submit a copy of the course completion certificate;
 - g) He has to return the salary and allowances drawn by his during the period of deputation in case of his failure to serve the Government at least two years from his return.


