In consultation with the Supreme Court of Bangladesh, Mr. Amit Kumar Dey, Deputy Registrar (Joint District and Sessions Judge), International Crimes Tribunal, Dhaka has been granted deputation from 26/05/2022 to 30/08/2023 for studying " Master of Health and Medical Law" at the University of Melbourne in Australia funded by 'Australia Awards Scholarship' of the Australian Government under the following terms and conditions :

- a. His period of deputation will be treated as on duty.
 - b. He will draw his pay and allowances in local currency.
 - c. He will return to Bangladesh after expiration of deputation.
 - d. Any stay abroad beyond the permitted period without prior permission of the Government of Bangladesh will be treated illegal.
 - e. He will not borrow any loan in abroad and will have to make payment of all the dues before his return.
 - f. As soon as the period of deputation ends, he will join the services and will have to submit a copy of the course completion certificate.
 - g. He will have to return the salary and allowances drawn during the period of deputation to the Government in case of his failure to serve the Government at least for two years from his return.
