

Notification

In consultation with the Supreme Court of Bangladesh, Mr. Forhad Mamun, Joint District and Sessions Judge, Narsingdi has been granted deputation from 11/09/2022 to 10/09/2025 and study leave from 11/09/2025 to 12/12/2025 for studying PhD in "Incorporating traditional knowledge in land record system in Bangladesh" at the Monash University in Australia funded by 'International Postgraduate Research Scholarship' under the following terms and conditions :

- a. His period of deputation will be treated as on duty.
 - b. He will draw his pay and allowances in local currency.
 - c. He will return to Bangladesh after expiration of deputation.
 - d. Any stay abroad beyond the permitted period without prior permission of the Government of Bangladesh will be treated illegal.
 - e. He will not borrow any loan in abroad and will have to make payment of all the dues before his return.
 - f. As soon as the period of deputation ends, he will join the services and will have to submit a copy of the course completion certificate.
 - g. He will have to return the salary and allowances drawn during the period of deputation to the Government in case of his failure to serve the Government at least for two years from his return.
