

Notification

In consultation with the Supreme Court of Bangladesh, Mr. Md Zaki Al Farabi (former Senior Assistant Judge, Sylhet), Attached Officer, Law and Justice Division has been granted deputation from 01/02/2022 to 31/01/2023 or for one (1) year from the date of departure for studying 'Master of Environmental Law' at the University of Melbourne, Australia funded by 'Prime Minister Fellowship' awarded by the Government of the People's Republic of Bangladesh, under the following terms and conditions :

- a) His period of deputation will be treated as on duty.
 - b) He will draw his pay and allowances in local currency.
 - c) He will return to Bangladesh after the period of deputation.
 - d) Any stay abroad beyond the permitted period without prior permission of the Government of Bangladesh will be treated illegal.
 - e) He will not borrow any loan abroad and will have to make payment of all the dues before his return.
 - f) As soon as the period of deputation ends, he will join the service and will have to submit a copy of the course completion certificate.
 - g) He will have to return the salary and allowances drawn during the period of deputation in case of his failure to serve the Government at least two years from his return.
2. This order is issued with the approval of the competent authority.


