
Notification

Terms and conditions:

- a) Period of deputation will be treated as on duty;
- b) He will draw pay and allowances in local currency;
- c) He will return to Bangladesh after expiration of deputation;
- d) Staying abroad beyond the permitted period without prior permission of the Government of Bangladesh will be treated as illegal;
- e) He will not borrow any loan in abroad and will make payment of all the dues before his return;
- f) The daily Mission Subsistence Allowance will be paid and temporary accommodation arrangements will be made by UNMISS;
- g) The “Guidelines on Non-Uniformed Civilian Government-Provided Personnel on Assignment with United Nations Peace keeping and Special Political Missions”, dated 1 April 2015, reference 2015.01, shall be applicable.


