

- d. Any stay beyond the permitted period without prior permission of the Government of Bangladesh will be treated as an illegal absence from service;
- e. He will not borrow any loan in abroad and he will have to make payment of all the dues before his return;
- f. As soon as the period of deputation ends, he will join the service and will have to submit a copy of the course completion certificate;
- g. He will have to return the salary and allowances drawn during the period of deputation to the Government in case of his failure to serve the Government at least two years from his return.
