

Notification

Ms. Fahima Akhter, Head Comparer, Chief Judicial Magistrate Court, Rangamati has been granted study leave from 21/01/2025 to 20/06/2026 for studying Master of Science in Business Analytics (MSBA) in affiliation with the International Pathway Program of 01 year 05 months at University of Hartford, USA, under the following terms and conditions :

- a) This study leave will not be deducted from her account of leave;
 - b) She will not receive any study allowances;
 - c) During her study leave she will be entitled to her salary on half-average pay basis;
 - d) The Government of Bangladesh shall not bear any expenditure in local or foreign currency for this study;
 - e) She will return to Bangladesh immediately after period of study leave;
 - f) Any stay abroad beyond the permitted period without prior permission of the Government of Bangladesh will be treated illegal;
 - g) She will not borrow any loan abroad and will have to make payment of all the dues before her return;
 - h) As soon as the period of study leave ends, she will join the service and will have to submit a copy of the course completion certificate on her return;
 - i) She will have to return the salary and allowances drawn during the period of study leave to the Government in case of her failure to serve the Government at least two years from her return.
