- i) He will have to return the salary and allowances drawn during the period of deputation in case of his failure to serve the Govenment at least one year from his return.
- j) All terms and conditions of the Public Administration Training Policy, 2023 and other related Rules and Regulations for training /studing abroad will be applicable.
