

**Notification**

In consultation with the Supreme Court of Bangladesh, the Government has granted deputation from 01/01/2024 to 01/01/2027 in favour of Mr. Shaikh Md. Mujahid Ul Islam, Attached Officer (Additional District Judge), Law and Justice Division for studying PhD on 'Synthesis of Sustainability through Legal Governance Mechanism' in the University of Malaya, Malaysia fully funded by the University Malaya Graduate Teaching Assistanhip Scheme (GTA) under the following terms and conditions :

1. The period of deputation will be treated as on duty.
2. He will draw his pay and allowances in local currency.
3. The Government of Bangladesh shall not bear any expenditure in local or foreign currency for this study.
4. Unless otherwise directed by the Government before completion of the study, he will return to the country immediately after completion of the course.
5. Any stay beyond the permitted period in Malaysia without prior permission of the Government of Bangladesh will be treated as an illegal absence from service.
6. He will not borrow any loan in abroad and he will have to make payment of all the dues before his return.
7. He will have to submit a copy of the course completion certificate on his return.
8. He will have to return the salary and allowances drawn during the period of deputation to the Government in case of his failure to serve the Government at least two years from his return.


