

Notification

In consultation with the Supreme Court of Bangladesh, the Government has granted deputation from 01/02/2024 to 21/12/2027 and special leave without pay from 22/12/2027 to 28/02/2028 in favour of Ms. Nusrat Jahan Urmi, Attached Officer (Senior Assistant Judge), Law and Justice Division for studying 'Operationalizing the Concept of Loss & Damage Funding with a view to Formulating a Legal Framework of Climate Justice' funded by Monash Graduate Scholarship (MGS) and Monash International Tuition Scholarship (MITS), in the University of Monash, Australia under the following terms and conditions :

Terms and condition :

- a) Her period of deputation will be treated as on duty and the period of special leave without pay will not be counted as her service;
 - b) She will draw her pay and allowances in local currency for the deputation period and will not be entitled to get pay for the period of special leave;
 - c) The Government of Bangladesh shall not bear any expenditure in local or foreign currency for this study;
 - d) She will return to Bangladesh after the period of deputation and special leave without pay;
 - e) Any stay abroad beyond the permitted period without prior permission of the Government of Bangladesh will be treated illegal;
 - f) She will not borrow any loan abroad and will have to make payment of all the dues before her return;
 - g) As soon as the period of deputation and special leave end, she will join the service and will have to submit a copy of the course completion certificate;
 - h) She will have to return the salary and allowances drawn during the period of deputation in case of her failure to serve the Government at least two years from her return.
