**Notification**


In consultation with the Supreme Court of Bangladesh, the Government has granted deputation from 01/07/2024 to 31/10/2026 in favour of the following Judicial Officers for studying 'LLM in Global Legal Practice' at the University of Keio, Tokyo, Japan funded by 'Japan Human Resources Development Scholarship (JDS)' under the following terms and conditions:

**Terms and conditions :**

- a) The approved period of deputation will be treated as on duty;
  - b) He/she will draw all parts of his/her pay and allowances in local currency;
  - c) The Government of Bangladesh shall not bear any expenditure in local or foreign currency for this study;
  - d) He/she will return to Bangladesh after the period of deputation;
  - e) Any stay abroad beyond the permitted period without prior permission of the Government of Bangladesh will be treated illegal;
  - f) He/she will not borrow any loan abroad and will have to make payment of all the dues before his/her return;
  - g) He/she will have to submit awarded certificate and a report to the Law and Justice Division within five days of his/her return to Bangladesh after completing the course;
  - h) He/she is ineligible to apply for permanent residency and citizenship while studying abroad;
  - i) The provision of Rule 34 of BSR (Part-1) will be applicable in connection with this approval;
  - j) He/she will have to return the salary and allowances drawn during the period of deputation in case of his/her failure to serve the Government at least one year from his/her return.
  - k) All terms and conditions of Public Administration Training Policy, 2023 will be applicable.
2. This order is issued with the approval of the competent authority.
