In consultation with the Supreme Court of Bangladesh, the Government of Bangladesh has granted deputation from 24/09/2024 to 15/10/2025 in favour of Ms. Shammi Akhter, Attached Officer (Additional District Judge), Law and Justice Division for studying 'LL.M (with Specialism) in law and Gender' in SOAS University of London fully funded by Chevening Scholarship under the following terms and conditions :

1. Her period of deputation will be treated as on duty.
2. She will draw her pay and allowances in local currency.
3. The Government of Bangladesh shall not bear any expenditure in local or foreign currency for this study.
4. Unless otherwise directed by the Government before completion of her study, she will return to the country immediately after completion of the course.
5. Any stay beyond the permitted period in London without prior permission of the Government of Bangladesh will be treated as an illegal absence from service.
6. She will not borrow any loan in abroad and she will have to make payment of all the dues before her return.
7. She will have to submit a copy of the course completion certificate on her return.
8. She will have to return the salary and allowances drawn during the period of deputation to the Government in case of her failure to serve the Government at least two years from his return.
