

Notification

In consultation with the Supreme Court of Bangladesh, the Government has granted deputation from 01/01/2024 to 31/03/2025 in favour of Ms. Ummul Aman, Attached Officer (Senior Assistant Judge), Law and Justice Division for studying 'Master of Intellectual Property Law' funded by the Australia Awards Scholarship 2024-2025, in the University of Melbourne, Australia under the following terms and conditions :

Terms and condition :

- a) Her period of deputation will be treated as on duty;
 - b) She will draw her pay and allowances in local currency for the deputation period;
 - c) The Government of Bangladesh shall not bear any expenditure in local or foreign currency for this study;
 - d) She will return to Bangladesh after the period of deputation;
 - e) Any stay abroad beyond the permitted period without prior permission of the Government of Bangladesh will be treated illegal;
 - f) She will not borrow any loan abroad and will have to make payment of all the dues before her return;
 - g) As soon as the period of deputation ends, she will join the service and will have to submit a copy of the course completion certificate;
 - h) She will have to return the salary and allowances drawn during the period of deputation in case of her failure to serve the Government at least two years from her return.
