

**Notification**

The undersigned is directed to convey the approval of the Government of the People's Republic of Bangladesh in favour of Mr. Md. Golam Sarwar, Secretary, Law and Justice Division, Ministry of Law, Justice and Parliamentary Affairs to attend the study tour, headed by the Hon'ble Chief Justice of Bangladesh, to the United States of America from March 25-29, 2024. The invitation, extended by the US Department of Justice, is intended to gather insights from the United States of America to assist in formulating sentencing guidelines for the judges in Bangladesh. The aforementioned approval is issued subject to the following terms and conditions:

- (a) The period of his participation in the study tour including transit will be treated as on duty.
  - (b) United States Department of Justice's Office of Overseas Prosecutorial Development, Assistance and Training (OPDAT) will cover economy class airfare, lodging, and incidental expenses, while the Government of Bangladesh will cover the remaining portion of the airfare according to entitlement.
  - (c) He will leave Bangladesh for the United States of America on 24 March 2024 or nearest possible date and will return on 30 March 2024 or nearest possible date.
