Terms and condition:

- a) The approved period of deputation will be treated as on duty;
- b) He will draw all parts of his pay and allowances in local currency;
- c) The Government of Bangladesh shall not bear any expenditure for this study;
- d) He will return to Bangladesh after the period of deputation;
- e) Any stay abroad beyond the permitted period without prior permission of the Government of Bangladesh will be treated as illegal;
- f) He will not borrow any loan abroad and will have to make payment of all the dues before his return;
- g) He will have to submit awarded certificate and a report to the Law and Justice Division within five days of his return to Bangladesh after completing the course;
- h) He is ineligible to apply for permanent residency and citizenship while studying abroad;
- i) He will have to return the salary and allowances drawn during the period of deputation in case of his failure to serve the Govenment at least one year from his return.
- j) All terms and conditions of the Public Administraion Training Policy, 2023 and other related Rules and Regulations for training /studing abroad will be applicable.
